- MerriMutts reserves the right to immediately change your dog’s type of boarding/daycare if we believe it is necessary to protect the health and well being of your dog, other dogs, or a staff member.
- MerriMutts cannot guarantee that toys, blankets, or beds will be kept in the same condition as brought into the facility.
- There is an addition charge when feeding your dog with “house” food. House food is Canidae (\$3 per day per dog) or Diamond (\$2 per day per dog). NOTE: We recommend that you bring in your own food since changing a dog’s food can cause a severe upset stomach.
- We offer a long-term boarding discount of 10% off for stays exceeding one week.
- MerriMutts reserves the right, without notice, to adjust its fees for services. Please inquire at the front desk as to our current fees.

1. You indicate your agreement with all the terms hereof,
2. You authorize MerriMutts Inn to obtain medical and vaccination records for your dog from the veterinarian listed above and you hereby authorize your veterinarian to provide these records to MerriMutts Inn.
3. You release, indemnity and hold MerriMutts Inn harmless from any and all manner of damages, claims, losses, liabilities, cost or expenses, causes of action or suits, whatsoever in law or equity (including, without limitation, attorney’s fees and related costs) arising out of or related to the services provided by MerriMutts Inn, except which may arise from the sole gross negligence or intentional and willful misconduct of MerriMutts Inn, including, without limitation: a)any inaccuracy in any statement made by yourself or information provided by you to MerriMutts Inn, b)your dog, including but not limited to destruction of property, dog bites and transmission of disease, and c)any action by yourself which is in breach of the terms and conditions of this Agreement.
4. This Agreement covers the current relationship between MerriMutts Inn and yourself. Each time you bring your dog to MerriMutts Inn, you affirm the terms of the Agreement and the truthfulness and accuracy of all statements you make in this Agreement.

To ensure your dog’s safety, as well as that of our existing MerriMutts Inn dogs, you are required to bring a copy of your dog’s updated shot records from your vet before you are allowed to start with us.
